

MEETING OF SWIMBRIDGE PARISH COUNCIL TUESDAY 8th AUGUST 2017 at 7.30 PM SWIMBRIDGE JUBILEE HALL MINUTES

Public Session

David Netherway would like to thank everyone who supported Swimbridge in the Bags of Help scheme. £1000 was awarded which will be shared among the community initiatives outlined in the application. The Green Team will meet this Saturday.

John Hayes asked if there had been any feedback from either Chittlehampton Parish Council or residents who had been transferred to their Parish in the boundary changes. The Clerk knows 2 families and one parish councillor, she will ask them for their thoughts on the outcome.

Mrs O'Hanlon spoke about the Tree Beech approval – report from her attached.

Rev Shaun O'Rourke asked the Parish Council to explain why they had cashed in the shares in Roberts Metal Packaging which actually belonged to the Parochial Church Council. Cllr Dodd explained that the fault lay directly in the hands of Roberts Metal Packaging who when offering the shares for sale had mistakenly concluded the designation 'Swimbridge PCC' in their records meant Swimbridge Parish Council and addressed the share sale offer to the clerk of the Council. Following subsequent communications the Company convinced the Parish Council that they were indeed the rightful owners of the shares. The church members were extremely unhappy and did not accept this explanation. It was agreed that the funds received by the Parish Council will be refunded to the Church Council.
